According to the decision on the sojourn tax No. 06-87 / 2008-5-02 dated 13.11.2008 (the "Official Gazette of the city of Cacak no. 9/208), the sojourn tax is not paid by: 1. Children under the age of 7, 2. Persons referred to the spa and climatic treatment i.e. specialized rehabilitation by the competent medical commission, 3. Persons who are staying in the tourist facility to perform research, environmental and similar actions, with the exception of athletes who are staying in the facility to train and compete 4. Foreign citizens who are, according to international conventions and agreements, exempted from paying the tax, 5. Persons who are staying at the facility for more than 30 days. The sojourn tax reduced by 50% is paid by 7-15 years old persons.

Persons from paragraph 1 of this article (membership card, certificate of school i.e organizers of working, research and environmental actions, persons referred by a medical commission, etc.)

In a receipt exemption from the sojourn tax is specifically stated. In the case of significant changes in the market and changes in prices of the elements of calculations, we reserve the right to change the price of unpaid amount of arrangements.
